- 15. Adopt performance standards and requirements designed to promote proper environmental, health and safety behaviors at Renner Italia and, where possible, at customers.
- 16. Preserve health, occupational safety and environmental protection through periodic workplace monitoring activities, with the aim of preventing unsafe behavior or dangerous situations.
- 17. Prepare for environmental, health and safety emergencies through open communication of our risks.
- 18. Promote waste management oriented to principles of reduction, recycling, reuse.
- 19. Optimize energy, raw materials and water consumption through research and development of increasingly advanced technological processes and the use of renewable energy, recyclable and/or reusable materials.
- 20. Prepare assessment of the business environment, including nature, size, significant changes in processes and/or facilities, because of the environmental impact and health and safety protection of workers.
- 21. Share with workers the company's objectives related to quality, environmental management and occupational safety.
- 22. Make the policy available to internal and external stakeholders and review it periodically to ensure that it remains relevant and appropriate to the organization.
